# WYOMING WINE DIRECT SHIPMENT INFORMATION -JULY 2025-

The following information is not all-inclusive. For more information and questions regarding licensing requirements, liquor laws and regulations, contact the Wyoming Liquor Division (WLD), Compliance team.

#### **DEFINITIONS:**

"Out-of-State Shipper" or "Direct Shipper" means any alcoholic liquor manufacturer, importer, wholesaler or retailer, licensed in its state of domicile, outside the State of Wyoming, and licensed by the State of Wyoming as a Direct Shipper, who accepts orders for manufactured wine, not listed with the Wyoming Liquor Division, placed from Wyoming customers and who ships, packages for shipment or facilitates in any way shipment of the wine by a third party or common carrier to any person, household or licensed wine retailer in Wyoming

"Listed" means a wine product currently sold by the Wyoming Liquor Division and listed in the Wyoming Liquor Division price book.

## SHIPPING TO CONSUMERS (Households):

Licensed Out-of-State Shippers may ship **up to 108 liters** of manufactured wine **not listed** with the Wyoming Department of Revenue Liquor Division directly to any one household within any twelve (12) month period <u>Direct shipment of malt beverages and/or spirits is prohibited.</u>

#### SHIPPING TO RETAILERS:

Licensed Out-of-State Shippers may ship **any wine not listed** with the Wyoming Department of Revenue Liquor Division directly to any retailer which holds a liquor license that can sell wine products. State law requires all listed wines to be distributed solely by the Department of Revenue Liquor Division. The Out-of-State Shipper and the licensed Wyoming retailer are responsible for ensuring only non-listed wines are directly shipped to retailers. **Direct shipment of malt beverages and/or spirits is prohibited.** 

# REQUIREMENTS AND CONDITIONS PRIOR TO SENDING ANY SHIPMENTS:

Prior to sending any shipment to any household or licensed retailer in Wyoming, the out-of-state shipper shall:

- The license term will be from July 1st to June 30th annually.
- File an application with the Department of Revenue Liquor Division,
- Pay a license fee of \$50.00 to the Department of Revenue Liquor Division. Fees are not pro-rated for first term licensure.
- Provide a true copy of your current alcoholic liquor or malt beverage license issued in your state of domicile,
- Provide other information as may be required by the Department of Revenue Liquor Division,
- Obtain an out-of-state shipper's license from the Department of Revenue Liquor Division.

### REQUIREMENTS AND CONDITIONS FOR LICENSED SHIPPERS:

Any licensed out-of-state shipper shall:

- Not ship more than 108 liters of wine to any one household during a license term,
- Not ship to any licensed retailer or any household in this state, any wine that is listed with the Department of Revenue Liquor Division,
- Offer to sell to the Department of Revenue Liquor Division, at wholesale prices, any particular wine where more than 90 liters has been shipped to any combination of households and retailers in the state,
- Ship wine only to an individual who is at least 21 years of age,
- Ensure all shipping containers are conspicuously labeled:
- "CONTAINS ALCOHOLIC BEVERAGES. ADULT (OVER 21) SIGNATURE REQUIRED FOR DELIVERY",
- Ensure all shipments are made by a duly licensed carrier and ensure such carriers comply with requirement to obtain an adult signature.
- Be deemed to have consented to the personal jurisdiction of the Department of Revenue Liquor Division, any other state agency and the courts of Wyoming concerning enforcement.
- Annually renew its license and pay a \$50.00 renewal fee.

# TAX PAYMENT AND REPORT REQUIREMENTS:

Any licensed out-of-state shipper shall:

- Remit a tax of twelve percent (12%) of the invoiced price of each wine shipment to the Department of Revenue Liquor Division,
- File a monthly report no later than the 10<sup>th</sup> of the month following the month of shipment. Attach copies of the invoices for each wine shipment coming into Wyoming indicate volume shipped per household, or retailer.
- Items shipped at no retail cost, not including shipping and handling fees, to any customer must have a written explanation for the no retail cost submitted with the applicable invoice(s).
- If no shipments were made during any month, Zero {0} reports are required.
- Email Zero Reports to: dirship@wyo.gov
- Maintain records for at least three (3) years and permit the division to audit records.

## PENALTIES:

Any person who makes, participates in, transports, imports or receives a shipment in violation of W.S.12-2-204 is guilty of a misdemeanor. Each shipment shall constitute a separate offense. Where the person holds an out-of-state shippers license, license suspension or revocation may be in addition to or in lieu of the foregoing penalties.

Any report filed late with the Department of Revenue Liquor Division shall be subject to a late filing fee of \$25.00.
