APPLICATION FOR CREDIT TERMS AND CONDITIONS

1. Application for Credit: Applicant hereby applies for credit from Red-D-Arc Limited (“Creditor”) for the purpose of renting, leasing or purchasing equipment. Applicant acknowledges and agrees that any such rental, lease or purchase and sale agreement shall be subject to such agreement’s specific terms and conditions. Applicant warrants that all information provided in this application is true and correct. Applicant authorizes Creditor to obtain credit reports and other financial information from time to time for credit evaluation purposes. Creditor reserves the right, in its sole and absolute discretion, to refuse to extend credit to Applicant at any time, for any reason or no reason, without notice or liability.

2. Payment Terms: Applicant agrees to pay all rental charges, fees, and other amounts due to Creditor in accordance with the terms specified in the applicable agreement or invoice. Unless otherwise specified, payments are due Net 30 days from the invoice date. A late payment charge of 1.5% per month or the maximum allowed by law may be applied to overdue balances. Delinquent accounts may be reported to the applicable credit bureau(s).

3. Default: In the event of default by Applicant, including but not limited to failure to make timely payments, Creditor may, at its option, declare all amounts immediately due and payable, repossess the equipment, and pursue any other remedies available at law or in equity.

4. Collection Costs: Applicant agrees to pay any and all costs and expenses of collection, including reasonable attorneys’ fees, incurred by Creditor in enforcing any terms of this application or any related agreement.

5. Governing Law: This application and any resulting agreements shall be governed by and construed in accordance with the laws of the Province of Ontario, without regard to its conflict of laws principles.

6. Entire Agreement: This Application for Credit constitutes the entire agreement between the parties with respect to the granting of credit from the Creditor to the Applicant and supersedes all prior agreements and understandings, whether written or oral.

The Creditor shall not be bound to exhaust its recourse against the Applicant or others or any securities or other guarantees it may at any time hold before the Creditor will be entitled to payment from the Guarantor under this Guarantee, and the Guarantor renounces all benefits of discussion and division and waives any right to require that any action be brought against the Applicant or any other person, or to require that resort be had to any security. The Guarantor agrees to pay all costs and expenses of collection, including reasonable attorneys’ fees, incurred by Creditor in enforcing this Guarantee.

The Guarantor consents to and authorizes the use of a consumer credit report on the Guarantor by Creditor, from time to time as may be needed for credit evaluation purposes.
